Some Cases Resolved by the Ombudsman

1. A Brgy. Captain was ordered Dismissed From The Service for Grave Misconduct as well as the filing of criminal charges in court for Violation of Section 3 (e) of RA 3019 in connection with the implementation of the <u>ESA</u> <u>Funds for Yolanda victims</u>.

Resolution dated March 27, 2017.

2. A Brgy. Captain, a Former Brgy. Kagawad & a Former Brgy. Treasurer were indicted in court for Falsification in connection with the purchase of sports supplies for the SK in 2009 amounting to P20,092.00.

In the administrative aspect, the **Brgy**. **Captain** was ordered Suspended for 9 months without pay for Less Serious Dishonesty.

Resolution & Decision dated Nov. 25, 2015.

3. A Mayor, an Agriculture Officer, and BAC Members were ordered DISMISSED FROM THE SERVICE for Grave Misconduct in connection with the awarding of the contract for the repair of mechanical grain dryers to Franmar Agro Industrial Sales in the amount of P698,000.00 <u>without</u> <u>public bidding</u>.

Decision dated January 3, 2017.

4. A Mayor was indicted for 4 counts of violation of Section 3 (h) of RA 3019 for allegedly rigging the bidding of several municipal projects in favor of Tri-B Marketing which is owned by an alleged domestic helper & dummy of the mayor's wife.

In the administrative aspect, the Mayor was found guilty of Serious Dishonesty & Grave Misconduct & was ordered DISMISSED FROM THE SERVICE.

Resolution & Decision dated Jan. 20, 2016.

5. A Mayor & a Municipal Treasurer were indicted for violation of the <u>GSIS Act</u> & <u>Home</u> <u>Development Mutual (Pag-Ibig) Fund Law</u> in connection with the delay in the remittances of members contribution covering the period from 2011 to 2012.

Resolution dated Feb. 16, 2016.

6. A City Mayor was Indicted for violation of Sec. 3 (e) of RA 3019 for the release of the amount of P500,000.00 from the PDAF of Sen. Loren Legarda to the Iloilo Press Club w/c is an non-accredited NGO & for his failure to monitor the implementation/ construction of the IPC building.

Resolution dated February 29, 2016.

7. A City Councilor was dismissed from the Service for Grave Misconduct for issuing truck ban exemptions to trucking companies & individuals operating within the city, which is the official function of the Traffic Authority in that city.

Decision dated September 2, 2016.

8. A City Mayor was Indicted for violation of Sec. 3 (e) of RA 3019 for entering into a lease agreement with Alfie Construction without being authorized by the Sangguniang Panlungsod & <u>without prior conduct of a</u> <u>public bidding.</u>

Resolution dated September 3, 2014.

9. A Mayor was suspended for 6 months & 1 day for Disgraceful & Immoral Conduct for having an illicit affair with a woman with whom he bore a son despite his subsisting marriage to his lawfully wedded wife.

Decision dated October 27, 2016.

10. A Mayor was indicted for violation of Sec. 2 of RA 1379 (Forfeiture of Properties Illegally Acquired) for allegedly acquiring cash & properties amounting to P60,573,024.00 which is way beyond his legitimate income.

Resolution dated November 2, 2016.

Role Of The Ombudsman In Criminal and/or Administrative Cases Filed Before It.

3 - Fold Liability of Erring Government Employees Criminal Liability -Imprisonment/ **Fine/Forfeiture Civil Liability** Damages (mental) **Penalties** Administrative Liability

The penalties in administrative cases:

- **1. Dismissal from the Service**
- 2. Forced Resignation / Advice to Resign
- 3. Demotion
- 4. Suspension
- 5. Forfeiture of Salary
- 6. Fine (not more than 6 months salary)
- 7. Transfer
- 8. Reprimand

*** Preventive Suspension - not a penalty but a procedural measure to secure the parties and / or evidence.

Grounds –

1. Complaint involves dishonesty, oppression, grave misconduct, neglect of duty or charges that would warrant removal from office.

2. Evidence of guilt is strong.

3. Respondent is in possession of documents or other materials which will be used as evidence against him.

4. Respondent is capable of intimidating or harassing the complainant or the witness/es to be presented against him.

Period of Preventive Suspension:

6 months for national government employees.

3 months for local government employees.

The investigation should be finished within these periods (6 months or 3 months) otherwise, the employee preventively suspended should be reinstated to his former position without loss of seniority or benefits. Know the rules so that you can break it properly.

Public office is a public trust. Public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, *integrity*, loyalty, and efficiency, act with patriotism and justice, and lead modest lives. (Section 1, Article XI, 1987 Constitution)

(The Code of Conduct and Ethical Standards for Public Officials and Employees)

What is ETHICS?

Comes from the Greek word "ethos" meaning "<u>character</u>";

Principles that govern the behaviour of a person <u>within a group</u> and/or in the <u>conduct of an activity</u>;

Rules of conduct recognized in respect to a particular class of human actions or a particular group or culture.

INTEGRITY

Thinking, speaking and doing what is right even if nobody is watching. Integrity is synonymous to CHARACTER.

Pride, Envy & Greed can become poisons to Integrity and/or Character.

Signs of Integrity

- 1. Taking ownership of one's actions.
- 2. Praising the accomplishments of others.
- 3. Keeping it clean during an argument.
- 4. Road rage restraint.
- 5. Putting others first.
- 6. Asking to hear the other side of the story.
- 7. Volunteerism.

Norms of Conduct of Public Officials and Employees

1. COMMITMENT TO PUBLIC INTEREST

Public officials & employees shall always uphold the public interest over & above personal interest.

All government resources & powers of their respective offices must be employed & used efficiently, effectively, honestly & economically, particularly to *avoid wastage in public funds* & *revenues*.

The contents of the four container vans were subsequently burned by virtue of Abandonment Proceedings No. 13-2017-6-2018 at the RRDS Petro Chemical Industries Inc. in Mandaue City on Oct. 3, 2018.

They shall at all times respect the rights of others, & shall refrain from doing acts contrary to law, good morals, good customs, public policy, public order, public safety & public interest.

Justness & Sincerity . . .

They shall not *dispense or extend undue favors on account of their office to their relatives whether by consanguinity or affinity* except with appointments considered strictly confidential or those whose terms are co-terminus with theirs. People really do not care what we know.

What is important is that people know that we care.

Persons with a heart for God have a heart for people. When it comes to service, God is more interested in our AVAILABILITY rather than our ABILITY, our **DISPOSITION** rather than our **POSITION**. Let us be an expression of God's love.

5. RESPONSIVENESS TO THE PUBLIC

Public officials & employees shall extend prompt, courteous & adequate service to the public. They shall provide information on their policies & procedures in clear & understandable language, ensure openness of information, public consultations & hearings whenever appropriate, encourage suggestions, simplify & systematize policy, rules & procedure, & avoid red tape.

What is **DEMOCRACY**?

Comes from the Greek word "demos" meaning "people" and "kratos" meaning "power".

> Literally it can be defined as "power of the people".

Statements and Disclosure (Section 8)

Statement of Assets, Liabilities and NetWorth (SALN)

Persons Exempted From Filing SALN

- Those who serve in an official honorary capacity, without service credit or pay
- Temporary laborers
- Casual or temporary and contractual workers

When to File SALN and Financial Disclosure

- 1. Within 30 days after assumption of office,
- 2. On or before April 30 of every year,
- 3. Within 30 days after separation from the service.

It was taken during the 1993-1994 famine in Sudan, by Kevin Carter, a South African photojournalist.



The amazing shot was widely circulated for which Kevin Carter won the Pulitzer Prize.

During one phone-in interview, someone called and asked Kevin Carter what happened to the girl.

He simply replied, "I did not wait to find out after the shot because I had a flight to catch".




Then the caller said, "I put it to you that there were two vultures on that day.
